Dear Mr. Robert

I am sitting here with a severe cramping across the bottom of my rib cage, which having had two acute bouts with pancreatitis, I am familiar with this being the warning sign of serious consequences to follow, possibly death if a full shut down occurs.

My mother will attest it is only a result of my cannabis use that she attributes my recovery from near death before, and prior to that she was die hard against my use. Now she is very concerned and if you could give her a call at 530-891-4909 she will confirm this.

Further the sensation I recognize as a highly enflamed adrenal gland of which I mentioned in your office the day of my release about the doctors having thought I had 3 kidneys. This is aggravated from all this stress we have been facing, as we are still undergoing harrasing actions of most likely the DEA Task Force Officer "TFO" people.

Mary was blatently followed by the same person staying within 10 feet of her all through the Dollar general store earlier today while she was shopping there and speaking with the manage, who asked who they were and why they were following her so close. As much as my daughter tried to shake him he relocated them and again began the pursuit of tailing them at different locations about town, such as when she left her dentist office.

The manager at the dollor general store is the mother of the young lady I spoke with you about on the phone that needed the counseling because of her husband's death on 1-11-05 that I performed both the funeral services and their Jewish/Christian marriage ceremony previously on 2-22-04. She has been extremely distraught because of this occuring to us on 2-22 the day she was visiting her husbands gravesite, and will only trust in my counseling because I was the only one that after several months of counseling both families and her and her husband prior to the wedding that allowed a beautiful cross-denominational ceremony to take place in front of what I was informed was attended by in excess of 250 people including the Orthodox Jewish members of the family that had previously declared they would not attend.

I am working on setting up a new fax machine and should have that done a little later tonight if I can manage to keep going with this pain I am experiencing.

Once this is set up I will fax you the Clergy Record provided by the funeral home that provided burial services. It list me as the Clergy. I will also fax copies of several of the marriage certificates from the clerk of the Superior Court of Graham County listing me as the person performing the weddings. Also I will be sending Mary's and My ID cards we presented, Kripners Membership application with signed pledge to our church and a discarded ID card made for kripner that was missing the Member Since date. If there is anything else I can think of or that you think could be useful let me know and I will send that as well.

The primary point of this letter is I am not doing very well, nor is Mary. We need an emergency order to modify our terms of release, or at least an expedited hearing on this matter. Prosecution is not being prejudiced, but we most certainly are sustaining irreparable injury.

The seriousness of our injury, physically, mentally, and to our substantive rights is compounding by the minute, and I believe there should be no doubt remaining as to our sincerety to this Zoroastrian faith we adhere. It is now time that the burden of

compelling interest and least restrictive means shift to the Prosecutor.
