COURT CALLS CASE: COUNSEL ARE PREPARED TO GO FORWARD ON APPEAL. MS. GOULD TO COURT REGARDING MEMBERS OF CHURCH WHO ARE KNOWN DRUG USERS AND ARE SEEKING FROM THE COURT TO CLARIFY THE ORDER OF RELEASE PREVIOUSLY SET BY JUDGE MARTINEZ. ARGUES TO THE COURT REGARDING DANGER TO THE COMMUNITY.
