Amended Petition for Action on Conditions of Pretrial Release

COMES NOW **Martin Martinez** - PRETRIAL SERVICES OFFICER presenting an official report upon the conduct of defendant **Timothy Jason Kripner** who was placed under pretrial release supervision by the Honorable **Lourdes A. Martinez, United States Magistrate Judge**, sitting in the court at **Las Cruces, New Mexico**, on April 9 2007, with conditions which included the following:

1. 7(p): Refrain from the use of unlawful possession of a narcotic drug or other controlled substances.
2. 7(q): Submit to any method of testing required by the pretrial services office to determine whether the defendant is using a prohibited substance:

RESPECTFULLY PRESENTING PETITION FOR ACTION OF COURT AND FOR CAUSE AS FOLLOWS:

On February 6, 2008, the defendant submitted a urine sample which tested positive for methamphetamine. On February 10, 2008, the sample returned confirmed positive for methamphetamine.


On February 21 & 25, 2008, the defendant failed to report to submit a urine sample for testing.

PRAYING THAT THE COURT WILL ORDER A WARRANT FOR THE DEFENDANT'S ARREST be issued to show cause why his conditions of release should not be revoked.




